STATE OF CALIFORNIA

Working within the guidelines set forth in a letter from the California Department of Justice Bureau of Firearms, Thordsen Customs LLC (with guidance from legal counsel) has determined that the FRS-15 Gen I, II, & III stock, when installed on a semiautomatic centerfire rifle WITH NO OTHER RESTRICTED FEATURES listed in California Penal Code 30515(a)(1)(A-F), **DOES NOT** meet the definition of an "assault weapon" and therefore may be configured with a detachable magazine and **DOES NOT** require mandatory registration.

CA ASSAULT WEAPON DEFINITION

California Penal Code Section 30500-30530

30515.

- (a) Notwithstanding Section 30510, "assault weapon" also means any of the following:
- (1) A semiautomatic, centerfire rifle that does not have a fixed magazine but has any one of the following:
 - (A) A pistol grip that protrudes conspicuously beneath the action of the weapon.
 - (B) A thumbhole stock.
- (C) A folding or telescoping stock.
- (D) A grenade launcher or flare launcher.
- (E) A flash suppressor.
- (F) A forward pistol grip.
- (2) A semiautomatic, centerfire rifle that has a fixed magazine with the capacity to accept more than 10 rounds.
- (3) A semiautomatic, centerfire rifle that has an overall length of less than 30 inches.

NEW YORK STATE

As witnessed by legal counsel retained by Thordsen Customs LLC and in cooperation with legal counsel representing The Gun Shop at McGregor's in Lake Luzerne. New York. Authorities representing New York State Police Division Counsel's office and the Office of the Attorney General of the state of New York verbally stated that the FRS-15 Rifle Stock, when installed on a semiautomatic centerfire rifle with **NO OTHER RESTRICTED FEATURE** listed in the New York Safe Act, **DOES NOT** meet the definition of an "assault weapon" and therefore **DOES NOT** require mandatory registration.

In order to comply with the NY Safe Act the conversion from a pistol grip to an FRS-15 stock should not be readily convertible or easily able to be reversed back to the pistol grip configuration. Although it is not required by law, a method demonstrating permanence (as suggested by New York authorities) is to fill the screw head or cavity with epoxy, silicone based caulk, or other permanent sealants.

NY ASSAULT WEAPON DEFINITION

New York Safe Act

- 22. "Assault weapon" means
- (a) a semiautomatic rifle that has an ability to accept a detachable magazine and has at least one of the following characteristics:
 - (i) a folding or telescoping stock:
 - (ii) a pistol grip that protrudes conspicuously beneath the action of the weapon;
 - (iii) a thumbhole stock;
 - (iv) a second handgrip or a protruding grip that can be held by the non-trigger hand;
 - (v) a bayonet mount:
 - (vi) a flash suppressor, muzzle break, muzzle compensator, or threaded barrel designed to accommodate a flash suppressor, muzzle break, or muzzle compensator;
 - (vii) a grenade launcher;
